A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF SPRINGDALE, ARKANSAS URGING ADOPTION OF THE SENATE REDISTRICTING LABELED "MAY 4 VERSION SENATE NORTHWEST."

WHEREAS, it has come to the attention of the City Council for the City of Springdale, Arkansas that the State is in the process of redistricting State House and Senate seats within the State of Arkansas;

WHEREAS, based on the 2010 census, the City of Springdale is now the fourth largest City in the State and in the past ten years, Springdale has grown by over 50% to approximately 70,000 people, and that increase translates to 24,000 people, by far the largest numeric growth in the State of Arkansas since the 2000 census;

WHEREAS, the City Council for the City of Springdale, Arkansas has reviewed several proposals for redistricting, and urges adoption of the "May 4 Version Senate Northwest;"

WHEREAS, some of the proposals would carve up the City of Springdale into three or four pieces that would simply be used as "filler" for other State Senate Districts;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF SPRINGDALE, ARKANSAS, that the City urges passage of the redistricting map labeled "May 4 Version Senate Northwest," which is the best option for the City of Springdale and its surrounding communities.
