

"BE IT RESOLVED BY THE QUORUM COURT OF ASHLEY COUNTY, ARKANSAS, as follows:

That the Arkansas Reapportionment Board having authority to determine territorial districts for state representatives and state senators, and the Secretary of State of Arkansas, be and they are hereby requested that in rezoning efforts for positions to include Ashley County, Arkansas, or parts thereof, they make every effort to keep Ashley County intact as far as possible rather than combine part or all of Ashley County with districts which are not representative of the citizens of Ashley County, Arkansas."

Other non-related business matters of the Quorum Court of Ashley County, Arkansas held at the meeting are not included in this certificate.


